A dual rate appliance(s) is present with a single-rate supply. A single-rate appliance has been used for the assessment. Changing the electricity tariff to an off-peak (dual rate) supply is likely to reduce fuel costs and improve the energy rating.

How this affects your energy bills

An average household would need to spend **£1,214 per year on heating, hot water and lighting** in this property. These costs usually make up the majority of your energy bills.

You could **save £757 per year** if you complete the suggested steps for improving this property's energy rating.
